ABSTRACT

Susan Abulhawa's Mornings in Jenin is a powerful narrative that portrays generations of a Palestinian family, capturing the trauma of displacement and the struggle for identity and resistance. While much of the existing research focuses on themes such as trauma, memory, and exile, the specific ways in which different generations experience and contribute to the construction of Palestinian identity remain underexplored. In the end, it emphasizes the role of intergenerational narratives in preserving collective memory and shaping identity that resists displacement and affirms existence.
